To achieve that mission, we focus our work on research, communications, and strategic planning in the core areas of reproductive health, nutrition, micronutrients, digital health, and community health.

M&IHC is based in the United States of America and has worked in over 50 countries. M&IHC's Hub of Global Health Independent Contractors is trusted by a diverse array of clients, including PATH, Population Services International (PSI), and the Food and Drug Administration (FDA). M&IHC is hiring an Independent Contractor to serve as a part-time and remote Global Family Planning and Reproductive Health Research Researcher.

The Roles: Global Family Planning and Reproductive Health Research Researchers

The Global Health Researchers will support an upcoming research project focused on family planning and reproductive health. These positions report directly to M&IHC's Executive Director and will work in collaboration with other researchers from M&IHC's Hub of Independent Contractors. These are <u>contract</u> roles that are 100% remote. The consultants will support this project on a part-time basis of 15-25 hours per week with a flexible schedule, largely up to the discretion of the candidate and confirmed prior to the position start date. We are hiring multiple researchers to support this work. We are looking for both individuals with qualitative experience and individuals with quantitative experience.

Responsibilities:

- Lead and Collaborate on Global Family Planning and Reproductive Health Research
 - Lead the design, execution, analysis, and presentation for a mixed methods research project. This will include collaborating with partners and stakeholders to design qualitative and quantitative research protocol tools in English. This protocol will undergo an Institutional Review Board (IRB) review process.
 - Once approved, the Family Planning and Reproductive Health Researcher Team will support the participant recruitment and data collection process that is being executed by an in-country research team.
 - As data is received and transcribed, the Family Planning and Reproductive Health Researcher Team will execute qualitative and quantitative data analysis, in collaboration with a co-researcher.
 - Data analysis will include collectively designing a codebook, conducting a qualitative statistical analysis (NVivo, Dedoose, etc.), executing a quantitative data analysis (Stata, R, Excel, etc.), and creating a report and/or presentation highlighting the research findings.
 - Recommendations from the report and/or presentation will support several years of program implementation that works to bridge the gap between research and program implementation.



Qualifications

- Experience working in global public health, ideally in one or more of M&IHC's core areas
- Experience working in reproductive health, family planning, sexual health
- Masters Degree, in a relevant field
- Experience conducting research
- Strong writing and editing skills
- Strong organizational and communications skills
- Demonstrated ability to work independently, with limited supervision, as well as in teams
- Fluent in English
